1. This Invitation to Bids follows the Procurement Notice (PN) PDA/TDRS/IT/HWSW/2025-26/03 for the subject Procurement which appeared on PPRA website dated **March 2026** and subsequently published in two daily newspapers.
2. The Procuring Agency has reserved the funds for the procurement planned during the financial year 2025-26. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the **Purchase Order/Contract** for the **Provision of IT Equipment for PDA**.
3. A **Single Stage, Two Envelope** procedures shall be adopted as per Rule 36 (b) of the Public Procurement Rules, 2004. (Hereinafter referred to as "Rules")
4. The bid/proposal to be attached on e-Pak Acquisition & Disposal System (**e-PADS**), comprising both the **technical proposal** and the **financial proposal**. **The bidder shall ensure that the attachment of bid/proposal on e-PADS is mandatory, failing which the bid shall be rejected.**

5. **Bid Declaration Form must be prepared separately for each lot. Combination of Bid Declaration Form against each lot may lead to rejection.**
6. **For any clarifications, it is mandated that bidders communicate exclusively through e-PADs. Any attempt to utilize alternative modes of contact will result in consequential actions, potentially including disqualification of the bidder(s).**
